



Calisthenics Association of WA Inc State Team Code of Conduct

As a member of the CAWA State Team, I agree to abide by this Code of Conduct at all times while I am representing the Calisthenics Association of WA Inc and acknowledge that any breach of this Code of Conduct may result in disciplinary action as outlined below.

I _____ agree to:

1. Represent CAWA in a manner which is befitting of a State Team Member, to bring honour and respect to the Association;
2. Adhere to all CAWA and ACF Policies;
3. Adhere to the CAWA State Team Policies;
4. Support and respect all members of the team;
5. Conduct myself in a manner which is conducive to my best performance;
6. Disclose to a team official any injury that may adversely affect performance;
7. Wear correct State Team Uniform as directed by team officials;
8. Attend all training sessions well presented, dressed in team leotard, team uniform and hair worn neatly in a bun;
9. Follow all directions given to me at all times by any team official;
10. Attend all team trainings and to be punctual to training;
11. Acknowledge that absences from training will only be allowed in exceptional circumstances and at the discretion of the State Team Manager;
12. Notify team personnel in advance of any absence from training due to illness;
13. Be courteous and considerate to the needs of others at all times;
14. Conduct myself in a manner which does not result in actions that could become dangerous to myself or others;
15. Not consume alcohol or any drug [except prescribed], attempt to purchase, or have another person purchase some on my behalf if I am under 18 years old;
16. Not purchase or supply alcohol or any drug to a minor if I am over 18 years old.

Consequences for Breach of the Code of Conduct

The State Team Manager in consultation with the Team Coach and CAWA President reserve the right to discipline any person in breach of this Code of Conduct in a manner which they deem is appropriate and fair at the time, or at a future time that is agreed upon. Breaches of the Code of Conduct will be dealt with on an individual basis and dependant on the severity of the breach, may require further direction from the Board of Management.

Breaches of this Code of Conduct, may result in any of the following consequences, depending on the severity of the breach:

1. Verbal warning;
2. Written warning;
3. Removal from the team;
4. Room changes while on tour;
5. Being sent back to the team accommodation immediately from where the breach has occurred;

6. Banning from celebration function;
7. A bond being placed on the individual for future participation in national championships;
8. A ban from CAWA and/or ACF sanctioned events in the future;
9. Immediately being sent home at the individual's expense; and,
10. Any other action/punishment deemed appropriate and fair by the Official [s] dealing with the case.
